What we do			
How does ITIC and BSSSWPA protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We will continue to enhance our physical, electronic and procedural safeguards as new technologies become available.		
How does ITIC and BSSSWPA collect my personal information? Definitions			
Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>ITIC affiliates include companies with an Investors Title name; financial companies such as Investors Trust Company; and nonfinancial companies such as Investors Title Management Services, Inc.</li> </ul>		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <i>ITIC and BSSSWPA do not share with nonaffiliates so they can market to you.</i>		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
